### TERMS AND CONDITIONS:

#### How to enter:

Entries can be submitted either:

(a) Online through the relevant page on Camden Council's website <https://bit.ly/mayorschristmascardcompetition>

OR

(b) Delivering the artwork and entry form to:

#### Eligibility:

Open to school children currently in Years 5 and 6.

Entrants must reside in and be currently enrolled at a school within the Camden Local Government Area.

Entry must include artwork that reflects the theme 'Christmas in Camden'.

Camden Council employees, volunteers, contractors, consultants, Committee members, their families and household members are ineligible to enter.

Entrants must understand, agree, and accept all Terms and Conditions detailed here and on the entry form.

#### Format/Categories:

##### Hand drawn category

Entries can be in any medium, including but not limited to paint, pencil, watercolour or crayon.

Entries are to be A4 in size, either portrait or landscape, and can be uploaded online in PDF, JPEG or HEIC format.

Mail and hand delivered paper copies will also be accepted but must be accompanied by a paper entry form and permission slip. These entries must be received (not sent) by the closing date.

#### **Digital category**

Entries must be designed digitally and submitted via Camden Council's website. Digital design means originated in digital form without any physical component e.g. scanning or photography of hand drawn art. Digital photography is otherwise permitted as a design element.

Entries are to be A4 in size, either portrait or landscape, and can be uploaded online in PDF, JPEG or HEIC format.

**Number of entries:** Only one entry will be accepted per entrant across both categories. Subsequent entries by the same entrant will be deemed invalid entries.

#### **Prizes:**

*Hand-Drawn Winner:* A prize valued up to \$100 (not cash); and a framed copy of the winning artwork; and 50 Christmas Cards with the winning artwork on them.

The Mayor will use the winning artwork as the Camden Council Christmas Card for 2024.

Winner is also invited to light the Christmas Tree with the Mayor at the Camden Council Christmas Events.

*Hand-Drawn Runner-Up:* A prize valued up to \$50 (not cash).

*Digital Winner:* A prize valued up to \$100 (not cash); and a framed copy of the winning artwork; and 50 Christmas Cards with the winning artwork on them.

The Mayor will use the winning digital artwork as the Camden Council Digital Christmas Card for 2024.

Winner is also invited to light the Christmas Tree with the Mayor at Council's Christmas Events.

*Digital Runner-Up:* A prize valued up to \$50 (not cash).
