- iv. make an application to the Governor through the Office of Local Government, under section 19 of the Land Acquisition (Just Terms Compensation) Act 1991, for approval to acquire the land by compulsory process by the publication of an acquisition notice in the NSW Government Gazette;
- v. classify the property on acquisition as community land under section 31 of the *Local Government Act 1993*; and
- vi. authorise the General Manager or their delegate to finalise and execute all relevant documents relating to the acquisition of the land.
