TERMS AND CONDITIONS:

How to enter: Complete Survey that is available by scanning the QR Code at the 2024 Camden Careers Expo held at Julia Reserve Youth & Community Centre (see staff for details).

When you have completed survey, you will be asked if you would like to enter the prize draw. You must click 'YES' on this question and enter your details to the draw.

Eligibility: Entrants must understand, agree, and accept all Terms and Conditions detailed here.

Entrants must understand, agree, and accept the Privacy Disclaimer in these Terms and Conditions as well the Camden Council website [Privacy Policy](#).

Entrants must validly complete the Careers Expo Survey and tick the box to enter to be entered into the draw.

Camden Council employees, volunteers, contractors, consultants, Committee members, their families and household members are ineligible to enter. Camden Careers expo exhibitors are also ineligible to enter.
